



MEMORANDUM OF UNDERSTANDING ON ACADEMIC & RESEARCH CO-OPERATION

Multanimal Modi College, Modinagar (hereinafter MMC) & Ginni Devi Modi Girls (PG) College, Modinagar (hereinafter GDM) recognizing the benefits to their respective institutions from the establishment to conclude this Memorandum of Understanding (MoU).

The MoU is to take effect from October 12, 2022:

- 1. The purpose of this MoU is to *develop academic and educational cooperation*, mutual understanding between the two academic institutions.
- 2. This MoU signifies a statement of intent to collaborate, but is *not* a legally binding document.
- 3. Two academic institutions agree to develop the following *collaborative activities* in the academic area of mutual interest on basis of equality and reciprocity
 - 3.1. Allow visit of students for the purpose of learning and knowledge sharing.
 - 3.2. Conducting collaborative activities in fields of mutual interest.
 - 3.3. Promoting other academic co-operation as mutually agreed.
 - 3.4. Organizing seminar, symposia, lectures, conferences within the objectives of each institution on mutual agreement and shared basis.
- 4. The development and implementation of *specific activities* based on this MoU will be separately negotiated and agreed between faculties, schools or institutes which carry out the specific projects using instruments available in Central Instrumental Facility (CIF).
- 5. Both institutions agree to carry out these activities in accordance with *the laws and regulations* of the respective states after full consultation and approval.

- 6. MMC, Modinagar and GDM, Modinagar *recognize the value* of this MoU to each other in promoting their programmes and activities, but any promotional material/activity which includes must be sent to and be approved by the respective institutions or any other person authorized by both the institutions before use and print. It is understood that the implementation of any of the types of co-operation stated shall depend upon the availability of resources and financial support at the institutions concerned.
- 7. Both institutions should undertake *collaborative research activities* under the MoU result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
- 8. This MoU may be *amended or modified* by a written agreement on mutually agreed basis signed by the head or representatives of both institutions.
- 9. In any case of *discontinuance*, the parties will honor agreed commitments either via the accepted arrangement or suitable alternative negotiated at that point.
- 10. The institutions will make suitable *arrangements* for the visiting students, Ph.D. scholars, faculty, staff and post-doctoral fellows.
- 11. Both the institutions will seek opportunities to *cooperate* in a variety of academic/research areas.
- 12. Both the institutions will extend *invitations* for attending scholarly and technical meetings/lectures and assist in making arrangements for attending national and international conferences.
- 13. Arrangements concerning specific details of *financial support* will be made by written agreement applicable to each particular situations and legal terms and conditions.
- 14. The *names, crests and logos* of the institutions are the intellectual property of those institutions and may not be used without the express written permission of the institution that owns a particular name, crest or logo.

The MoU will be for 5 (Five) years in the first instance, and will be reviewed thereafter. Each party has the right to discontinue the arrangement subject to a period of 6 months' notice in advance. The MoU may also be terminated at any time by mutual consent of both the parties. However, such termination shall not affect participating Student/Researcher to complete the semester/work in which he or she is then enrolled/working under this MoU.
